ORDINANCE NO. 2021-2153

ORDINANCE APPROVING THE REALIGNMENT OF FUNDS ORIGINALLY INTENDED FOR THE CONSTRUCTION OF MUNICIPAL ENGINEERING BUILDING TO BE ERECTED AT THE BACK OF THE MUNICIPAL BUILDING, BARANGAY TIMUGAN AMOUNTING TO TWELVE MILLION PESOS (P 12,000,000.00) TO CONSTRUCTION OF WAREHOUSE AND WORKING AREA WITH THE SAME AMOUNT AND LOCATION, THEREBY AMENDING MUNICIPAL ORDINANCE NO. 2020-2060.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. RATIONALE. The Sangguniang Bayan of Los Baños has enacted Municipal Ordinance No. 2020-2060 entitled “Ordinance Approving the Supplemental Budget Amounting to Thirty-One Million One Hundred Eighty-Five Thousand Pesos and 01/100 (P31,185,587.01) Chargeable Against the Savings from Current Personal Services and the Beginning Balance CY 2020 on October 7, 2020”. The Construction of Engineering

Building in the amount of P12, 000,000.00 was among the projects funded by the said supplemental budget.

On May 14, 2021, the Local Chief Executive has communicated with the august body for change of project title, particularly for Construction of Engineering Building to be erected at the back of the municipal building to Construction of Warehouse and Working Area with same amount and in the same location covered by Municipal Ordinance No. 2020-2060. Another letter was received by the sanggunian on June 10, 2021 for the realignment of funds of the abovementioned project.

SECTION 2. AMENDMENT. The herein specified project is hereby realigned as follows:




